

Keep'in it Reel Fishing Charters Liability Waiver

I, _____, hereby acknowledge and agree to the terms and conditions set forth by Keep'in it Reel Fishing Charter for participation in ocean fishing activities off the coast of Vancouver Island.

1. **Assumption of Risks:** I understand and acknowledge that ocean fishing involves inherent risks, including but not limited to, rough seas, adverse weather conditions, equipment malfunctions, sunburns, insect or animal bites, and encounters with marine life. I voluntarily assume all such risks and accept full responsibility for any injury, loss, or damage that may occur as a result of my participation in the fishing activity.
2. **Health and Physical Condition:** I state that I am physically fit and do not have any medical conditions that would prevent me from safely participating in ocean fishing activities. I agree to disclose any medical conditions or physical limitations that may affect my ability to participate in these activities. I understand that the vessel has very limited medical facilities and in the event of illness or injury, treatment will be delayed until transportation to a proper medical facility is arranged. I certify that I have sufficient health, accident, and liability insurance to cover any bodily injury or property damage. If I have no insurance, I certify that I am capable of personally paying for any and all such expenses or liabilities.
3. **Safety Equipment:** I agree to comply with all safety instructions provided by the captain of the fishing vessel. I understand that life jackets and other safety equipment are provided for my use and agree to wear them as directed by the captain.
4. **Release of Liability:** In consideration of being permitted to participate in ocean fishing activities, I hereby agree not to sue Keep'in it Reel Fishing Charters, its owner, and affiliates from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any personal items lost or damaged, or injury, including death or drowning, that may be sustained by me or any activities when participating in fishing with Keep'in it Reel Fishing Charters.
5. **Indemnification:** I agree to indemnify and hold harmless Keep'in it Reel Fishing Charters, its owner, and affiliates from any and all liabilities, damages, costs, or expenses, including reasonable attorneys' fees, arising out of or related to my participation in ocean fishing activities.

I consent to the use of any photographs, videos, or other media taken of me during the fishing trip for promotional or marketing purposes by Keep'in it Reel Fishing Charters.

I have read this waiver and fully understand its terms and conditions. I acknowledge that I am signing this waiver voluntarily and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law. I understand and assume the risks and hazards associated with this activity.
